

## Parental Waiver, Release of Liability, Indemnification and Consent Form

I, the undersigned, as the parent or legal guardian of the child named below, do hereby give my full consent and approval for my child to participate in tennis and/or golf lessons provided by Michael E Gunsallus and assigns, D/B/A Kidz Tennis and/or Kidz Golf as outlined below.

I understand that there are certain risks of damages and injuries, including death, inherent in the practice and play of both tennis and golf, as well as in traveling in other related activities incidental to my child's participation, and I am willing to assume these risks on behalf of my child. These risks include, but are not limited to, those hazards associated with weather conditions, travel, playing conditions, equipment and other participants.

I understand that the motion of swinging a club and/or racket can be dangerous to my child and other players and may result in serious injury or death.

I understand that the very nature of tennis and/or golf can be hazardous and risky, including, but not limited to, the acts of swinging a club and/or racket, having a tennis ball hit back at the opponent, being in the path of a stray ball, running, jumping, stretching, diving and collisions with other players, volunteers and stationary objects, all of which can cause serious injury or death to my child and to other participants.

Further, I agree that in consideration for the right to allow my child to participate in tennis lessons provided by Michael E Gunsallus and assigns, D/B/A Kidz Tennis and/or Kidz Golf and in consideration for permission to play on the courts, driving ranges, or golf courses as arranged by Michael E Gunsallus and assigns, D/B/A Kidz Tennis and/or Kidz Golf:

1. On behalf of my child and myself, I do voluntarily elect to accept and solely assume all risks of injury incurred or suffered by my child (a) while practicing or playing as a member of a team if so designated, (b) while serving in a non-playing capacity as a team member or observer during practice or play by other teams or by other players, and (c) while on or upon the premises of any and all of the fields arranged for by the team for the purpose of practice or play.
2. In addition to giving my full consent for my child's participation, I do hereby waive, release, discharge and agree not to sue the individual or businesses designated below; Michael E Gunsallus, Kidz Tennis, Kidz Golf, the owner or operator of any court, driving range, or other playing field, or any person or entity connected with the program, for any claim, damages, costs including attorneys fees, or cause of action which I or my child have or may have in the future as a result of damages, injuries, including death, sustained or incurred by my child from whatever cause including, but not limited to, the negligence, breach of contract or wrongful conduct of the parties hereby released.

I hereby certify that my child is fully capable of participating in tennis and/or golf and that my child is healthy and has no physical or mental disabilities or infirmities that would restrict full participation in these activities.

I further agree on behalf of myself and my child listed below, that I shall hold harmless and fully indemnify the parties hereby released from any and all claims, damages, costs including attorney fees, and causes of action which may arise from any cause of action made by me or by, through or on behalf of my child, even if the damages, injuries or death are caused in whole or in part by any of the persons or entities hereby released.

I acknowledge (a) that I have read (or have had read to me) each and every one of the provisions in this waiver, release of liability and indemnification agreement, (b) that I understand each of the provisions in this agreement and (c) that I agree to abide by them.
